**The State of Florida Mandates a \$30.00 One Time Fee, Payable at Orientation (Cash or Money Order) Indigent Screening Approved Payment:** \$10.00 per session. Sliding scale Documentation of income (pay stub with current year-to-date information or tax returns) must be provided at orientation to received consideration for the following scale:

<u>Income</u>	<u>Session Fee</u>
\$0 - \$20,000	\$20.00 - 25.00 per session
\$20,001 - \$25,000	\$25.00 -30.00 per session
\$25,001 - \$30,000	\$30.00 – 35.00 per session
\$30,001 – higher	\$35.00 – 40.00 per session
